Fees

Our fees are based on the cost of providing services. We are competitively priced and those individuals in our three-county service area may be eligible for a fee adjustment for some programs and services if they qualify under Indiana's Hoosier Assurance Plan. Such eligibility is based on family size, income, and level of disability, and is determined at the time of the first appointment. We also are providers in many insurance plans, and depending on policy coverage, costs will be determined. Payment plans can be designed, if needed.
